Although not perfect I SUPPORT Bill 57 CD2 and Bill 90

We in the neighborhoods of Oahu have been struggling with Monster Homes for the past decade. We have been so active as to have gone to DPP and gotten all the documentation regarding over 40 homes that were built. While doing the analysis we discovered the same "actors" in the DPP and in the Electrical Contracting Field and the Plumbing Contracting field and the same "owner builder" selection on the applications.

Since computers don't lie, we found for the most part the City and County of Honolulu failed to do their work as required by law. Inspections were not done, yet signed off by our local DPP inspectors. Sometime it was so blatant that no inspection was done at all with no signatures. Clearly these "HUIs" knew what they were doing, and were using the same template to get what they wanted. They knew the shortcomings in our laws, and they knew what people were "available" to thwart the intentions of the laws.

Although we brought all of this to the attention of Kathy Sokagawa, we received little support. We attended every session, council meeting and every group we were invited to. Our results were miserable for years. No one wanted to "rock the boat".

It is my belief that the catastrophe of the Kealoha case became the deciding factor to listen to us. As we dug deeper the possibility of prosecution of wrong doing become more and more probable.

Thanks to our Council members action was finally taken and an ordinance was passed which set new standards for building which would prohibit Monster Homes.

Make no mistake, Monster Homes are not large extended family Homes, they are apartment buildings illegally built within residential zoning areas. The people who are behind this "take over" of Hawaiian land use CASH, which is a high incentive when you are talking well over a million dollars per parcel. But the proceeds of renting 20 rooms out to university students at going rate is so profitable that these illegal "Monstrosities" are worth the risk.

Even today we are still dealing with sites which were cited over 6 years ago. Non-compliance, Non-enforcement, No real financial hardship imposed, and no will to foreclose due to non-payment of the fines.

We simply must stop this illegal operation of a few bad players.

This is not about affordable housing. In fact the rentals are at the highest rate the market will bear.

There is a mistaken perception that we need more housing on Oahu, and that may be somewhat true, but only at the lower end of the market.

Low income = \$85,000.00 per year, Moderate income = \$120,000.00 per year. But I think what we are all really intending to talk about is Very Very Low Income which is \$35,000.00 per year. None of these Monster Homes provide either low income and certain no very very low income housing.

They are therefore counterproductive. Instead they ruin the texture of historic neighborhoods and insult the residents of Oahu, who get little if any relief from their constant illegal activity. The cementing over of an entire lot remove permeable land from our areas causing flooding. No required expanded sewer systems to accommodate such large structures overwhelm our exiting systems. The impact upon the electrical grid is immense, and we are sorely lacking in the infrastructure needed to maintain the constant barrage of such density within residential neighborhoods.

The mere aspect of parking makes living in the neighborhoods adjacent to these Monster Homes a daily nightmare.

In the end, the negative emotions generated by these illegal structures will not be helpful to the state which is dependent upon the citizenry to cooperate with other largescale projects for the common good.

RE: Bill No. 90 Relating to Building Permits

My name is Dwight Mitsunaga, 2020 President of the Building Industry Association of Hawaii (BIA-Hawaii). Chartered in 1955, the Building Industry Association of Hawaii is a professional trade organization affiliated with the National Association of Home Builders, representing the building industry and its associates. BIA-Hawaii takes a leadership role in unifying and promoting the interests of the industry to enhance the quality of life for the people of Hawaii. Our members build the communities we all call home.

BIA-Hawaii is opposed to Bill No. 90, which proposes to amend Section 18-6.4 of the Revised Ordinances of Honolulu, by removing any extension of the processing time for applications relating to a one-family or two-family detached dwelling or duplex with a floor area ratio that exceeds 0.6, for which plan review fees have been paid and for which no permit is issued within 365 days. The current law allows for extension of the expiration date by a building official.

The bill does not provide any rationale as to why the expiration date on certain residential projects cannot be extended. Given the current delays in processing building permits, the proposed bill would appear to create more frustration for those who are seeking to proceed with the lawful construction of a one or two family residence.

We are opposed to Bill No. 90 as currently drafted. We appreciate the opportunity to express our concerns on this bill.
