RESOLUTION

CONFIRMING THE NOMINATION OF DEAN Y. UCHIDA TO SERVE AS THE DIRECTOR OF PLANNING AND PERMITTING OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (2017 Edition) ("Charter"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the City Council ("Council"); and

WHEREAS, Charter Section 6-1501 establishes the Department of Planning and Permitting, headed by a Director of Planning and Permitting; and

WHEREAS, Charter Section 6-1503 sets forth the powers, duties, and functions of the Director of Planning and Permitting; and

WHEREAS, Charter Section 6-1502 requires that the Director of Planning and Permitting shall have had a minimum of five years of training and experience in a responsible planning position, at least three years of which shall have been in a responsible administrative capacity in charge of major land utilization activities.; and

WHEREAS, Charter Section 4-104.1 requires that each department head be a registered voter of the City; and

WHEREAS, by Mayor's Message 21, dated January 8, 2021 the Mayor has nominated Dean Y. Uchida to serve as the Director of Planning and Permitting; and

WHEREAS, after review of the nominee's qualifications, the Council finds that Dean Y. Uchida is qualified to serve as the Director of Planning and Permitting, and warrants confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Dean Y. Uchida is confirmed as the Director of Planning and Permitting of the City and County of Honolulu; and
