### Resolution 21-22 Testimony re. DPP Nominee Uchida

Aloha Committee Chair Elefante, Vice Chair Kia'aina and Committee Members Cordero and Say:

Concerns within the larger community are plentiful relating to this particular appointment, and while I do not know Mr. Uchida and have nothing against him personally, major concerns center on the heavily-weighted baggage he brings to this forum as a former lobbyist for the Land Use Research Foundation – the developer's lobbying group.

The concerns are these:

First, the telling avalanche of special-interest support from the Development industry, including heavy-duty developers and construction and development contractors.

Second, the Development industry's constant calling out for relaxed Zoning regulations and DPP requirements; their push to build up to property lines, as we have experienced with monster houses; and their ultimate demands for increasingly higher and denser buildings within our established communities and neighborhoods, culminating with their seeking and receiving zoning variances from the City Council to achieve these purposes.

The prospective DPP director's application states that he will be primarily responsible for:

"Developing and amending the General Plan and Development Plans. Process(ing) land development permits & entitlements (i.e. zone change, SMA, varience (sic), etc."

In 2020, the Kailua community found it necessary to rise up and defend their established community and protective zoning regulations to succeed in halting a misplaced Kawainui development project. As of the last City Council meeting the North Shore community achieved a vastly improved Koʻolau Loa Sustainable Community Plan, together with communities from Kahala to Hawaii Kai now seeking to secure an improved East Honolulu Sustainable Communities Plan. Further, the Primary Urban Center Development Plan review is also forthcoming with its established guidelines and some beneficial environmental improvements that should not be compromised.

Over the years, many concerned constituents striving to protect our established communities from over-development have succeeded together with the City Council to maintain our land use protections and zoning laws. But with this nomination we fear that the island that is our home and legacy for future generations will suffer from excessive changes that this appointment portends.

We would strongly object to these important plans for O'ahu's future and established zoning laws being watered down, streamlined, or compromised with variances galore once this candidate is at the helm of DPP with the thrust of his supporters in the Development industry.

O'ahu's established communities must be respected, and protective zoning laws must be honored – not compromised or diluted.
