Chair Waters stated his appreciation for the hard work done by Oceanit. He stated that through public participation and Oceanit's help, there will be no condemnation of private property at this time. He noted that the CD1 repeals Resolution 19-182 which allows the acceptance of both the Federal funds and the matching State funds. Chair Waters stated that there was \$240 million from the Federal Government and \$125 million from the State Government and if Resolution 19-182 is repealed, it would send the wrong message to the Federal Government that the City is not in support of the flood mitigation project. Chair Waters stated that at this time, the Army Corp of Engineers does not have a time line to re-scoping the project, the project is over budgeted by \$300 million, and the Corps will need to re-work the entire project. He noted that if the CD1 is approved, Oceanit would receive an additional \$575,000, for a total of about \$1.2 million. Chair Waters stated that it would be more appropriate to wait to see when the project is re-scoped and if the Council approves it, then go out to bid.

Councilmember Fukunaga stated that she agrees with the Chair's decision if a contract should or should not be issued for further consulting work but disagrees with the perspective that this is not the time for further engineering analysis. She noted that when there is a major cost overrun acknowledged by the Army Corp of Engineers, it is time to have additional analysis and technical review done to identify the best solutions moving forward. Councilmember Fukunaga stated that she will not be supporting the amendment. She noted that her support for the CD1 is based solely on the need to have additional technical review and she is not disputing the Chair's ability to cancel any contract he chooses to.

Councilmember Tupola stated that she needs to know the difference between the CD1 and FD1 because of the amount of time that Councilmember Fukunaga spent on the project to not support the FD1. She noted that she would like to review the measure further to make sure the right decision is made.

Questor Lau of Michaels Development Company gave a brief presentation on the Halewaiolu Senior Development project.

In response to councilmembers, Natalie Mesa, Michaels Development Company and Karen Seddon, Halewaiolu Senior Development stated that:

 After the extension, the lease would terminate and the land would revert back to the City. A meeting was held in July 2020 with Lum Sai Ho Tong, the Mayor, the Department
of Land Management and the developer to discuss air quality concerns and the
30-foot setback. At the conclusion of the meeting, Lum Sai Ho Tong requested
another air quality study. The three prior studies of the air quality showed no
significant impact so no further study was needed.

In response to councilmembers, Dean Uchida, Director Designate, and Joyce Shoji, Land Use Permit Division, Department of Planning and Permitting (DPP) stated that:

- Under the current zoning, a setback is not required.
- The exemption is not from a Land Use Ordinance requirement so the applicant may come before the Council in the future.
- The DPP will enforce the conditions adopted through the Resolution and have a
 development agreement to ensure the project will be built in a timely manner and in
 accordance with the Resolution.
- The DPP could help to revise, adjust or amend the agreement and once the development agreement is approved, then the building permit could be approved.
- In the 2016 Resolution, there were five conditions required by the Council for the DPP which were not conditions to qualify for the 201H exemption.

Councilmember Fukunaga explained that the action that the Council took in 2016 was to approve the development agreement between the Michaels Development company and the City and to address air quality issues. Councilmember Fukunaga stated that the Department of Health opined that generally they do not recommend residential facilities to be built close to crematory facilities, but they also stated that this was a City zoning decision. She stated that she supports senior housing but based on the concerns from the testimonies, she will be voting in opposition to the amended Resolution and hopes that the neighbors and developers can come together.

Councilmember Tupola thanked the Department and staff members for their response to the questions. She stated that the air quality concerns raised were resolved by the four different air quality surveys showing no significant impact in air quality. Councilmember Tupola noted that as one of the testifiers stated that the people of Hawaii are waiting on the Council to have more affordable housing for kupuna. She stated that she will support the project because of her questions raised were answered and she hopes that the Council can move forward on the project.

Councilmember Elefante stated his support of the Resolution. He thanked the members of the Zoning and Planning Committee and also those who provided testimony. Councilmember Elefante stated that this is a much needed project for the area for the seniors. He recognized and respect the concerns from Mr. Lum of Lum Sai Ho Tong and hopes that the Michaels Group and the development team will continue to work with the surrounding community throughout the process.

Councilmember Kiaʻāina thanked Chair Elefante for his leadership on this very difficult issue. She stated that she looks forward to working with Mr. Scott Hayashi, Director Designate, Department of Land Management and Mr. Dean Uchida, Director Designate, Department of Planning and Permitting to identify City land in each councilmember's district. She also urged greater collaboration with other agencies as well as the private sector and communities to move projects forward. Councilmember Kiaʻāina stated that she looks forward to working with the Administration and councilmembers to have more affordable housing projects on City lands.

Councilmember Say stated that with the understanding that the Resolution does not have any effect on 201H projects, he will be changing his vote. He noted for the record that he voted no in the Zoning and Planning Committee. Councilmember Say noted that he understands the need for more affordable housing and senior housing but he is concerned that another project will be added to the City inventory. He noted another concern he has is that services are being duplicated by the State and other agencies and maybe there should be one entity which he will be discussing in the Budget Committee. Councilmember Say stated he is changing his no vote to with reservations.

Councilmember Tsuneyoshi expressed her appreciation to Councilmember Fukunaga who is very invested in her community in the Chinatown area and addresses all their issues and concerns. She stated that after hearing all the testimonies today and the studies that were done, the DPP will continue to work through the process. She stated she will be voting with reservations. Councilmember Tsuneyoshi noted that this is a viable project and that the City should work together to bring it to fruition because it is needed, it will be beneficial to the area, and it will clean up the area.
