The Board of Water Supply (BWS) strongly supports Resolution No. 21-34, CD1, urging increased flexibility for electronic participation in and public access to meetings of City and County of Honolulu boards and commissions, City Council, and other city agencies to increase and assure effective citizen participation.

Since the start of the COVID-19 pandemic and the subsequent shutdown, the BWS looked for ways to ensure public participation in its board meetings and community outreach. We had the unique opportunity with the public hearing for Haiku Stairs in April 2020 to test ourselves, and our technology, to offer as many points of access as possible for the public to testify on what was a very important issue for the community.

Our communications team worked closely with our IT division to provide video and call in options. We also allowed for written testimony to be emailed in during the hearing and offered live stream options on Facebook and Vimeo. We were very proud of our efforts and many community members commended BWS for its efforts to ensure the public had a chance to express their concerns.

Since that time, we have continued with call in and of course written testimony. While we have been airing our board meetings on Olelo (after the fact), we have also continued with live stream feeds on Facebook and Vimeo. We are now looking at live video testimony options as well.
